The streamlined and focused working groups within the Executive Committee have been working well and to task. Exec meetings have been kept to a minimum, and selected members have been drawn in to contribute to each meeting.

A brief Executive meeting took place immediately after the 2019 AGM in Birmingham, since when various members have met in person a total of four times, in June, October, December and February. The April meeting to plan our 2020 conference was cancelled due to COVID-19, and since Lockdown in March, all NASACRE business has been conducted remotely. When it became clear that we were not going to be able to meet together for our 2020 Conference and AGM, we hastily pulled together an additional SACRE *Briefing* to add to the regular editions that we endeavour to send out for the start of each term, ready to support SACREs when they meet. We hope that these communications serve their intended purpose of keeping all members in touch with developments in the world of RE, and offering suggestions of matters for your consideration and discussion at your SACRE meetings.

We welcomed our Patron, Charles Clarke, and the soon-to-be-outgoing Chief Exec of the RE Council, Rudi Eliott Lockhart to our latest Exec meeting in February. This meeting was held over 2 days so that we could have a full and frank discussion about the way we hope to take our **NASACRE Development Plan** forward, in partnership with other organisations such as the REC and AREIAC (Association of RE Inspectors, Advisers and Consultants) to move forward with the recommendations of the 2018 CoRE report.

However, what we can say now is that, hopefully, we shall be putting everything on hold and saving it for a year hence. In the light of the fact that we cannot hold face to face elections for a new Exec to serve up to 2023, your current committee has agreed to keep the status quo, and noone is stepping down. In addition, we must not forget Marie Cooper (who was hoping to come and say Hello to everyone at conference!) and thank her profusely for continuing to provide a consistently high standard of paid Admin support.

This year we are saying an extra BIG Thank You to Paul who has, probably been the longest-serving Chair in NASACRE history, having taken the role on early through a quirk of fate and completed very nearly 4 years as Chair! He's been counting down to his handover to Robert for some time, and I'm sure although that will happen (very quietly!) on 18 May, and there'll be noone gathered to give him a clap, you'll join me in thanking Paul sincerely for everything he has done to serve our association. I feel sure we can all make it up to Paul later, because he's not going far... as Exec Assistant. We wish Robert well as he takes over from Paul and we are especially grateful to Linda who has been nominated for the Vice-Chair's role. As Paul becomes Exec Assistant, Lesley Prior has kindly agreed to continue working with us as a coopted member. There were no new nominations for any of the Exec positions; existing members were renominated by their respective SACREs and therefore everyone is elected unopposed.
